San Giovanni in Marignano, 8th July 2008, Aeffe S.p.A. communicates today that, in conforming with the programme approved by the Shareholders meeting held on March 3, 2008, the Group, in the period between 1th and 4th July, has repurchased a total number of 164,000 Aeffe ordinary shares, at an average price of 1.49 euro for a total countervalue of Euro 0.2 million.

From the beginning of the programme, the Group has repurchased a total number of 818,500 Aeffe ordinary shares (0.76% of the share capital) for a total countervalue of Euro 1.3 million.
