### **Aeffe: Buy Back Programme**

**San Giovanni in Marignano, 23<sup>rd</sup> September 2008**, Aeffe S.p.A. communicates today that, in conforming with the programme approved by the Shareholders meeting held on March 3, 2008, the Group, in the period between 15<sup>th</sup> and 19<sup>th</sup> September, has repurchased a total number of 170.338 Aeffe ordinary shares, at an average price of 1.27 Euro for a total countervalue of Euro 0.2 million.

From the beginning of the programme, the Group has repurchased a total number of 2,021,787 Aeffe ordinary shares (1.88% of the share capital) for a total countervalue of Euro 2.9 million.
