**Aeffe: Buy Back Programme** 

**San Giovanni in Marignano, 13<sup>th</sup> January 2009,** Aeffe S.p.A. communicates today that, in conforming with the programme approved by the Shareholders meeting held on March 3, 2008, the Group, in the period between 22<sup>nd</sup> December and 9<sup>th</sup> January, has repurchased a total number of 277,800 Aeffe ordinary shares, at an average price of 0.68 Euro for a total countervalue of Euro 0.2 million.

From the beginning of the programme, the Group has repurchased a total number of 4,568,121 Aeffe ordinary shares (4.25% of the share capital) for a total countervalue of Euro 4.8 million.
