**Aeffe: Buy Back Programme** 

**San Giovanni in Marignano, 20<sup>th</sup> January 2009,** Aeffe S.p.A. communicates today that, in conforming with the programme approved by the Shareholders meeting held on March 3, 2008, the Group, in the period between 12<sup>th</sup> and 16<sup>th</sup> January, has repurchased a total number of 143,950 Aeffe ordinary shares, at an average price of 0.70 Euro for a total countervalue of Euro 0.1 million.

From the beginning of the programme, the Group has repurchased a total number of 4,712,071 Aeffe ordinary shares (4.39% of the share capital) for a total countervalue of Euro 4.9 million.
