Aeffe: Buy Back Programme

San Giovanni in Marignano, 31st March 2009, Aeffe S.p.A. communicates today that, in conforming with the programme approved by the Shareholders meeting held on March 3, 2008, the Group, in the period between 23rd and 27th March, has repurchased a total number of 80,500 Aeffe ordinary shares, at an average price of 0.59 Euro for a total countervalue of Euro 0.047 million.

From the beginning of the programme, the Group has repurchased a total number of 5,488,321 Aeffe ordinary shares (5.11% of the share capital) for a total countervalue of Euro 5.298 million.
