San Giovanni in Marignano, 21st April 2009, Aeffe S.p.A. communicates today that, in conforming with the programme approved by the Shareholders meeting held on March 3, 2008, the Group, in the period between 14th and 17th April, has repurchased a total number of 105,517 Aeffe ordinary shares, at an average price of 0.653 Euro for a total countervalue of Euro 0.069 million.

From the beginning of the programme, the Group has repurchased a total number of 5,824,538 Aeffe ordinary shares (5.43% of the share capital) for a total countervalue of Euro 5.502 million.
